Dear Sir/Madam,

I am directed to state that the Executive Committee of the Council of Architecture (COA considered the assessment report of the Inspection Committee that conducted inspection at your Institution (copy enclosed), duly scrutinised by the Scrutiny Committee of Experts, together with the information provided by institution, for extension of approval of **Master of Architecture (M.Arch.) degree course**. The Executive Committee also considered request of the institution from change of nomenclature of course from M.Arch.(Architecture Education) to Master of Architecture

The Executive Committee, after having considered the same, has decided to grant extension of approval to **Master of Architecture degree course** at your institution as under:

DETAILS OF THE COURSE	INTAKE	PERIOD OF APPROVAL
2-year Full-time Master of Architecture degree course	20	2022-2023

The approval accorded by the Council to your institution is subject to compliance of the Council Norms attached herewith as **Annexure-A**. The approval accorded to your institution shall be subject to appointment of adequate Faculty of Architecture at your institution as per Council Norms, prior to commencement of academic session 2022-2023. The institution shall be required to appoint faculty to fill up any vacancy, as may be required, within 15 days in case of any faculty leaving the institution.

The Inspection Committee noticed the following serious issues affecting the working of the institution and proper studies of the students. The issues must be addressed in a time bound manner and compliance be submitted to the Council :

- Institution must recruit 1 Professor before the commencement of academic session.
- The core faculty is common to the UG and PG program hence the concerns of the faculty remain the same as reported in the UG inspection report.
- The faculty for PG course should be exclusive and must not be shared with UG course.
- Adequate Infrastructure and cadre-wise qualified faculty as per COA Norms should be appointed/ maintained by the institution at all times.
- Institution is required to take remedial action on all issues mentioned in the Council's letter dated 20.09.2022 communicating approval for B.Arch. course to the institution as well as assessment reports of the Inspection Committee.

The institution shall initiate necessary remedial actions, based on the observations of the Executive Committee & Inspection Committee and shall submit its compliance/observations on the same for further consideration. The Council shall be at liberty to inspect the Institution at any point of time to verify the compliance made by the institution and to ascertain that the institution is imparting architectural course as per the Norms prescribed by the Council, from time to time.
